As you indicate in your letter we have begun a dialogue with Novalpina and are in the process of arranging further discussions involving senior staff in order to ensure that the concerns outlined in our press release are fully answered. The information provided in your letter will undoubtedly be helpful in taking this dialogue forward and giving context which will help us to understand whether the answers which we are provided with adequately address the underlying issues.

The Authority takes its responsibility to invest responsibly and ensure that both those who manage money on its behalf and investee companies behave with proper regard to environmental social and governance issues, and we provide scheme members with considerable information in our annual report and through our website on our activities in this area, in particular voting records and engagement activity. This is an area where it is always possible for us to improve and we continue to seek to do so, based on the core principle of being as transparent as possible with scheme members.

I will respond more fully to the specific questions in your letter when we have concluded the next stage of our dialogue with Novalpina.
